

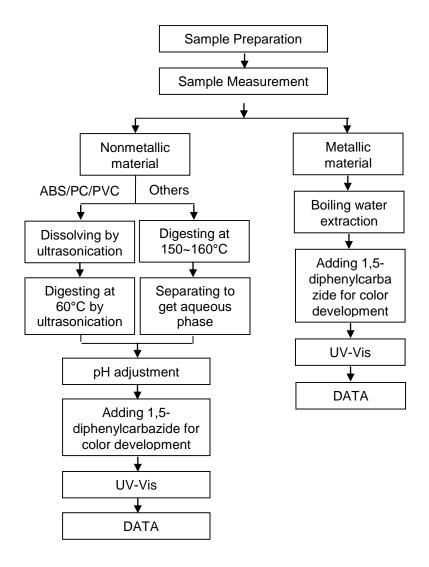



#### **PBB/PBDE Testing Flow Chart**





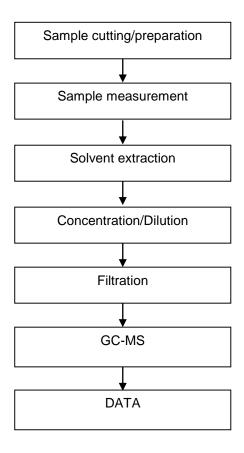

#### **Phthalates Testing Flow Chart**






